While Harvest Global Capital Investments (Cayman) Limited is the manager of the relevant fund, the investment committee of the fund comprises a representative from the fund manager, and a representative from each of its two investors, being Kung Chak Ming and Jee Up Enterprises Limited. Accordingly, each of Kung Chak Ming and Jee Up Enterprises Limited has control over the business and affairs of Harvest Global Dynamic Fund SPC acting on behalf of and for the account of Harvest Environmental Investment Fund SP (the "SPC"), including making investment and divestment decisions and voting the securities and interests held by the SPC, including those in the Company. Huang Bohao is the sole shareholder of Jee Up Enterprises Limited. Pursuant to Section 4 of the SFA, each of Kung Chak Ming, Huang Bohao and Jee Up Enterprises Limited is deemed to have an interest in the Shares held by the SPC.

On 17 July 2025, Jee Up Enterprises Limited acquired 180,620,574 shares pursuant to a married deal, which are held by Jee Up Enterprises Limited through a sub-account with Tiger Brokers (Singapore) Pte. Ltd. as the depository agent. Accordingly, Jee Up Enterprises Limited is deemed to have an interest in the 180,620,574 shares held by Tiger Brokers (Singapore) Pte. Ltd..
